SUPPLEMENTARY REGULATIONS

- 1 The Southsea Motor Club Ltd will organise a National B Sporting Trial at Langrish, Nr Peterfield, Hants, GU32 1QY (map reference 197/SU702240) on Sunday 27 March 2011.
- 2 The meeting will be governed by the General Regulation of the MSA Ltd (incorporating the provisions of the International Sporting Code of the FIA), these SRs and any written instructions the organising club may issue for this event.
- 3 RAC MSA permit number:- National B: 61417
- 4 The event is open to all fully elected members of the organising club and members of the following invited clubs:-

BTRDA, SportingTrials.com and the 750 Motor Club.

The event counts towards the 2011 BTRDA Sporting Trials Championship, The 2011 MSA British Sporting Car Trial Championship and The REIS ASWMC Sporting Trials Championship.

Drivers must produce a valid Competition Licence and valid membership card from the organising club or one of the invited clubs. All passengers must produce a valid membership card from the organising club or one of the invited clubs.

- 5 Public roads will not be used to link the sections. There will be 3 rounds of at least 8 sections on private land. The entry will be split into groups, starting at different hills to enable the programme to be completed.

SCRUTINEERING STARTS AT 9.00AM. FIRST TEST STARTS AT 10.30AM. CLOCKS GO FORWARD THIS WEEKEND.

ANY COMPETITOR NOT SIGNED ON BY 10.15AM MAY BE EXCLUDED.

- 6 All cars will comply with the RAC MSA technical regulations and with the RAC National Formula.
- 7 Awards will be presented as follows:-

Best performance of the day:	President's Trophy & Replica
Best performance in Red Class:	John Fisher Cup & Replica
Best performance in Blue Class:	Southsea Autosport Challenge Bowl & Replica

Best performance in Green Class:	Stanley Faulkner Challenge Trophy & Replica

- 15 Starting numbers will be allocated by ballot.
- 16 All competing cars must be fitted with an effective silencer.
- 17 The use of motor cycles on the site is restricted to authorised persons only.
- 18 No person may drive a competing car on the site except the authorised competitor.
